

#### WOOD DUST

Information from IARC – International Agency for Research on Cancer.

1991 TLV-TWA = 1mg/m<sup>3</sup> - Hard wood 5mg/m<sup>3</sup> - Soft wood

#### PHYSICAL FORM

Wood is a complex biological and chemical material consisting primarily of cellulose, hemicellulose and lignin. The two general classes are hard wood and soft wood, each with its own structure and composition. Woods also may contain a variety of organic compounds, including glycosides, quinones, tannins, stilbenes, terpenes, aldehydes and couramins. Not only is the composition of wood extremely variable from species to species, but different parts of the same tree may have different compositions. Various solvents, adhesives, fungicides, insecticides and micro-organisms also may be associated with wood.

#### TOXICOLOGY

Wood dust exposure may cause eye and skin irritation, respiratory effects and hard wood nasal cancer. Irritation of the skin and eyes resulting from contact with wood dust is relatively common.

Allergic dermatitis arising from exposure to wood substances may progress to vesicular dermatitis after repeated exposures. The hands, forearms, eyelids, face, neck and genitals generally are first affected. Allergic dermatitis may appear after several years contact, but typically ensues after a few days or a few weeks of contact.

Respiratory ailments associated with wood dust exposure include irritation, bronchitis, nasal mucociliary stasis, impairment of ventilatory function and asthma.

Obstructive lung disease, as measured by pulmonary function tests, has been associated with wood dust exposure.

A hypersensitivity reaction leading to asthma (defined as reversible airway obstruction) has been reported from exposure to wood dusts. Connecting asthma to wood dust exposure has been difficult because, frequently, the subject has worked with wood for years with no reaction. Sensitisation typically begins as eye and nose irritation, followed by nonproductive cough and difficulty in breathing.

The association between nasal cancer and occupations involving exposure to wood dust has been established from

case reports and epidemiologic studies. The relationship was first noted in the late 1960s in Great Britain, where the incidence of nasal adenocarcinoma, a rare type of nasal cancer, among woodworkers in the furniture industry was found to be 100 times greater than in the general population.

Although estimates of the relative risk of nasal adenocarcinoma vary considerably because of differences in exposure levels, types of wood dust, latency periods, selection of controls and other confounding factors, the IARC has concluded that there is sufficient evidence that nasal adenocarcinomas have been caused by exposure in the furniture-making industry. The carcinogenic agent(s) in wood dust have not been identified.

Other cancers, including lung, Hodgkin's disease, multiple myeloma, stomach and colorectal cancer and lymphosarcoma, have been mentioned in relation to wood dust exposure. Data is insufficient and inconclusive regarding the relationship between occupational exposure to wood dust and cancers other than nasal adenocarcinoma.

I have been advised that a member has questioned the propriety of a payment which was made to me last year by the Executive Committee, and I seek the chance to explain the situation.

In 1995 Western Australia was scheduled to become the host State for the Australian Woodcraft Federation, and I was nominated by the Woodturners Association to become President of the Federation. My nomination was supported by the other West Australian members, ie: The Fine Wood Association, The Fine Wood Industry Project and The Guild of Wood Carvers, and I decided to go to Adelaide, at my own expense, to attend the AGM of the Federation and to accept, on behalf of all the members of those other organisations, the office of President. Nancy Launer and David Eyres were nominated and accepted as Secretary and Treasurer respectively. While in Adelaide, as well as attending the formality of the Federation AGM, I was invited to attend the AGM of the South Australian Woodgroup and the monthly workshop meeting of the Group, and four other woodcraft centres and also attended a Display by the SA Woodgroup at the Peter Waite Homestead, the Waite Arboretum, and the Tool Museum at Myponga. At the Tool Museum, I was invited to do an impromptu demonstration of thread cutting on the lathe. At all these venues, I spread the gospel of WAWA to the best of my ability, and was very well received.

Although I had not requested financial support, the Executive Committee decided, in my absence, to give me the sum of \$200, which represented approximately a third of my expenses, and I accepted this gratefully.

Those members who have heard me speak about the Woodcraft Federation at our meetings, or who have read in the Australian Woodworker magazine of my activities in the interests of woodturners, will already have some appreciation of the situation. To those who have not, I offer this explanation, with the hope that if the member concerned continues to pursue the issue, you will understand and endorse your Committee's action.

#### NOTICES OF MOTION To be put to the Annual General Meeting 14th September, 1996.

Pursuant to Clause 32 of the Constitution of the Woodturners Association of Western Australia Inc, notice is hereby given of intention to propose the following motion at the forthcoming annual general meeting.

#### MOTION 1.

That two thousand dollars (\$2,000) be given to each group, to be used for the purchase of equipment or for reasons which the group may deem necessary to promote the art of woodturning. All equipment purchased by the said group will remain the property of the Western Australian Woodturning Association (Inc.).

#### MOTION 2.

The group responsible for a monthly weekend workshop, shall be responsible for all expenses involved during said workshop. All profits that remain will be the property of the said group, less 10% which will be paid to the Western Australian Woodturning Association (Inc.).

My reasons for proposing these motions: MOTION 1.

Over \$60,000 is held by the Association which belongs to the members and therefore should be used to benefit all members now. Several groups have requested much needed equipment and have been refused said equipment for their members. Every year each group's accounts is audited. Each group should be trusted to handle their affairs.

#### MOTION 2.

The groups put the work and time into their weekend workshops. A profit after expenses of \$500 or more is made from some weekend workshops. The groups should be able to purchase equipment for their own group for the purpose of promoting woodturning. The group does the work, they should be able to reap the rewards for all their members. This will not only make the members of the groups happier, it will also build up the morale of the groups and this in turn will flow back to the Association.

Pursuant to Clause 32 of the Constitution of the Woodturners Association of Western Australia Inc, notice is hereby given of intention to propose the following motion at the forthcoming annual general meeting.

With the probable increase in funds becoming available to the groups for the purchase of equipment, it is important that only financial members should benefit from such a plan. It is for this reason, that at the next Annual General Meeting, I wish to put the following motion:

#### MOTION 3.

Any group including non-members in their group's activities be delisted and not receive the benefit of any equipment or fund allocation.

 (C) The said Equipment Committee to convene at least once yearly and in addition as often as such Committee deems necessary in pursuance of its duties; and

- (D) The duties of the Equipment Committee shall be to -
  - (a) determine the nature of the equipment which should be supplied by the Association to Groups established within the Association;
  - (b) establish a level of such equipment which should be so supplied;
  - (c) in the light of findings by the Equipment Committee under sub-paragrahps (a) and (b) above, to determine the shortfall in equipment currently held by established Groups;
  - (d) estimate the cost of providing the equipment so identified under sub-paragraph (c) above; and
  - (e) submit to the Management Committee at least once yearly recommendation(s), categorised as being – (a) highly desirable, or
     (b) desirable

to address the shortfall in equipment so determined.

- The Equipment Committee, in its deliberations, to take due regard to the level of Association membership and activity within individual Groups established under the Association.

The Management Committee shall, at each Annual General Meeting, report to the members the action taken by that Committee to address shortfalls of equipment determined by the Equipment Committee and, where such determined shortfalls have not been remedied, the action proposed by the Management Committee to address such remedy.

#### **Dr HENRY WALKER**

enry was born in London, almost in a taxi on London Bridge. As it happened, his mother did make it to the hospital. His father was a medical officer in the British regular army and consequently Henry spent most of his first ten years of life in various postings in the Far East.

The family returned to the UK in 1936 and as his father was being moved in his postings so often his mother moved house 25–30 times during their marriage. Henry only remembers swimming and playing and nothing of school while in the Far East but he attended preparatory school in Lee–on–Solent and then moved to a school in Cranbrook, Kent at the start of the war.

Because of fear of invasion they were transferred to Kelly College in Tavistock, Devon. He says that he always had great difficulty with Latin as a subject, but it was necessary if one wanted to study medicine. When he matriculated, he attended Bristol University doing first year medicine.

After first year, he joined the RAF as an "erk" (Aircraftsman 2). He trained at Skegness, Lincs where they had to drill in full kit in freezing temperatures. From there he did a six months radar course becoming a radar mechanic.

In 1944 he was posted to Dum Dum, outside Calcutta in India where they were billetted in Clive of India's house. Incidentally, Dum Dum is where the name for the dum dum bullet originated. After the war ended, almost all of the RAF personnel stationed there went on strike because they had not been sent home, but Henry did not believe it was the right thing to do. Consequently, he was "sent to Coventry" by his colleagues. To rub salt into their wounds, because he had done a year at University, he was sent home to complete his medical degree – paid for by the RAF.

On graduation, Henry completed his internship at Bristol and then undertook a GP training course. Strange as it may seem, there was at that time, a surplus of doctors and after applying for something like 20 positions all over the world, he was offered a job in Three Springs in WA. He started there in 1955 and stayed until 1964.

In 1964 he returned to the UK for nine months doing various postgraduate courses before returning in 1965 to join a large group practice in Midland. He stayed there for 18 years and found it a most satisfying career. After leaving Midland, he practised Occupational Medicine on a part time basis working for many of the largest firms in Perth. In 1987 he retired fully.

Henry became interested in wood turning by watching exhibitions at various shopping centres. While visiting the UK once again, he participated in a wood turning course there. When making enquiries about equipment, he had the opportunity to buy a Tough lathe together with some tools. On another visit to the UK, he did a five day course with particular emphasis in working on hollow forms.

Henry is always a keen participant at the weekend workshops and always has good contributions to make in both questioning demonstrators and in taking part in show and tell. His particular interest is finding an irregular piece of wood, preferably full of holes and seeing what thing of beauty can be produced from it. Despite this particular bent, he still has all his fingers.

Henry's other great interest is sailing and boats. He was a keen sailor from 1965 to 1986 building his own boat in 1979.

He is a keen supporter of the "Leeuwin" sail training ship and is also a maintenance helper on the "Endeavour". His interests in wood and boats have given him great satisfaction.

#### DEPTH GAUGE

A cheap depth stop for drills is a piece of garden hose. It will fit over many woodworking drills and can be cut to any length. It does not have to be fastened by screws and it does not mark the timber. I have used this idea for many years and have learnt to cut the hose a little bit longer, to allow for the give in the material for when it butts against the wood. I have also found that the same hose material makes an excellent protective tip for narrow chisels, particularly those used for carving.



#### FINDING THE CENTRE OF CIRCLES

You may vaguely recall from school geometry that the angle in a semi-circle is a right angle. Conversely then, if the angle is a right angle, then the hypotenuse must pass through the centre, that is, it must be a semi-circle.

To find the centre of a disc, lay a sheet of writing paper on it. One corner must touch the circumference. Hold it firm and note where the two sides of the sheet cut the circumference. Make marks here. Draw a fine line between the two. The centre could be found by marking off half this distance. More accuracy is achieved if the process is repeated elsewhere on the disc, giving an intersection. This is the centre.

For even greater accuracy, particularly in the case of a roughly sawn disc, repeat yet again. This may give a triangle of error. Estimate the centre of this small triangle.



A large Perspex set-square, if available, is more convenient than using a piece of paper, but certainly not worth buying for this purpose alone. A sheet of cardboard or the corner of a sheet of ply can be used for larger discs.



• Mrs Thora Smith has advised that she is unable to continue as reception desk co-ordinator. Her departure will be truly missed. • Injuries to Members. It has been brought to the attention of the Committee the necessity for members to be registered in their correct full name. A recent Court decision in Perth found against a sporting club where one of its members was injured whilst participating in a Club sporting event. The Club made a claim on their insurance to recoup the outlay for the iniured member's medical expenses. The insurance company under the "Freedom of Information" legislation obtained a copy of the Club's membership list and learnt the person injured was registered under the name eg: TOM SMITH when in fact his correct name was THOMAS SMITH. Using this loophole, the Insurance company refused the claim. Ensure that this doesn't happen in our Club as the Association would be powerless to assist any incorrectly registered members. The Management Committee asks any person who falls into this category to please make sure that the Membership Secretary has you registered under your correct full name.

Milton Rundle advised at the May Meeting, he had been informed that the Freedom of Information Act did not apply to the Association and it was up to the claimant to ensure the correctness of any information shown on any claim form against the Association's insurance policy.

• Wandi Group have advised that since taking delivery of a Vicmark mini lathe, problems have arisen with the index pin. The Safety Officer is investigating this problem and will submit a full written report to the Committee. The Commitee will advise the Manufacturer of the findings.

• Certificates for Demonstrators. The Committee has been asked whether certificates could be provided to demonstrators. The Association does not normally issue certificates to demonstators and instructors and the member making the enquiry has been informed of this.

• 1996 Wildflower Exhibition. The Kings Park Board has invited the Association to participate in displaying and selling turned items at this year's Wildflower Exhibition to be staged over 10 days. A stall in a 3m x 3m tent will cost \$1500 with a \$200 for a second tent and \$100 for power. Commission of 10% will be payable on all sales in excess of \$15000. It was resolved to reject the invitation due to cost, staffing requirements and cramped conditions.

• The Annual General Meeting of each group should be held in August so that the names of the Office Bearers are in the hands of the Secretary for inclusion in the October/November Newsletter, which is prepared for publication in mid-September.

### CHAIN SAW SAFETY KICKBACK

#### WHAT IS KICKBACK ?

The word kickback is used to describe the sudden reaction that happens when the upper quadrant of the tip of the bar (known as the "kickback zone") touches an object and the saw is kicked backwards.



Kickback can happen very suddenly and violently; kicking the saw, bar and chain back at the user. If this happens when the chain is moving it can cause very serious, even fatal injuries. It is vital you understand what causes kickback and that you can avoid it by taking care and using the right work technique.

Kickback always occurs in the cutting plane of the saw. Normally the saw and bar are thrown backwards towards the user. However, the saw may move in a different direction depending on the way it is being used when the kickback zone of the bar touched the object.



### KICKBACK PREVENTION

- Maintain firm grip (thumb behind front handle !) and good footing.
- Cut at peak revs.
- Be aware of where the nose of the bar is at all times.
- Avoid limbing with upper section of nose bar.
- ✓ Sharpen correctly and maintain proper depth gauge setting.
- Maintain correct chain tension.
  Use a property functioning
  - Use a properly functioning chain brake.
